A. PERSONNEL

1. Approve, upon the recommendation of the Superintendent, the appointment of **Morgan Carroll** as a Part-Time Special Education Teacher at the E.G. Hewitt School, at BA Step 1 \$49,325 prorated (\$21,210), 3 hrs./day, 5 days/week (.43), no medical benefits, effective September 1, 2010 for the 2010-2011 school year. This new position is required due to the increase in the number of special education students.
2. Approve, upon the recommendation of the Superintendent, the appointment of **Karen Lavin** as a Part-Time Basics Skills Teacher at the Peter Cooper and M. J. Ryerson Schools, at MA Step 6 \$56,200 prorated (\$28,100) 2 ½ days/week (.5), no medical benefits, effective September 1, 2010 for the 2010-2011 school year. Ms. Lavin is replacing Lisa Hroncich who was appointed to 3rd Grade at the Peter Cooper School
3. Approve, upon the recommendation of the Superintendent, the appointment of **Hayley Romano** as a Part-Time Enrichment Teacher at the Robert Erskine and Peter Cooper Schools, at BA Step 1 \$49,325 prorated (\$24,663) 2 ½ days/week (.5), no medical benefits, effective September 1, 2010 for the 2010-2011 school year. Ms. Romano is replacing Krystina Mongelli who transferred to 3rd Grade at the Peter Cooper School.

Approve, upon the recommendation of the Superintendent, the appointment of **Bridget Zachgo** as a Part-Time Art Teacher at the Robert Erskine School, BA Step 1 \$49,325 prorated (\$19,730) 2 days/week (.4), no medical benefits, effective September 1, 2010 for the 2010-2011 school year. This position is being filled because of the retirement of Judy Parsils, Art Teacher.

5. Approve, upon the recommendation of the Superintendent, the appointment of **Casey Reno** as an ABA Therapist for the Teen R.E.A.L.M Programs at the M. J. Ryerson School, at Step 1, 21.00/hr., for 5.98 hrs./day, 5 days/week, for a total of 29.9 hrs/week, no medical benefits, effective September 1, 2010 for a probationary period of 90 days (November 23, 2010) for the 2010-2011 school year.

6. Approve, upon the recommendation of the Superintendent, the appointment of the following **summer custodial help**, at the rate of \$8.25/hr. from 6:30am to 3:00pm effective as listed. Hours worked will be documented by time sheets.
